

Boneo Park Media Accreditation

Process & Guidelines:

Boneo 🎙 Park

To be accepted to attend events at Boneo Park, representatives of media organisations must apply for the media accreditation using the correct form. Media Accreditation forms are valid for 12months.

Once media accreditation is accepted interested parties are also required to complete and return the attached application form two weeks out from major events to confirm their attendance. To gain access to Boneo Parks monthly competitions an email requesting approval to attend the specific event is accepted.

All Applications must be sent to the Marketing Manager and be approval prior to each major event.

On the day of the event, approved applicants will need to present themselves to the event office to be checked in, briefed and received event pass if required.

Boneo Park has the sole discretion to accept, vary or reject any applications for media accreditations in part or in full. Media representatives must be respectful of the competitors and not evoke horses spooking or affect the horse and riders performances. Media must abide to signage and arena fencing.

To apply for accreditation you must supply:

- Five (5) High resolution images of horses in action from the event. Please send at latest three days after closure event. (Via Drop-box is accepted)
- One (1) passport style photo of yourself (digital only, physical photographs will not be accepted).
- One (1) example of published work.
- A brief overview of the events you intend to attend.
- Media Accreditation is valid for 12 months, you must email prior to all events you wish to attend for event preparation.
- Present a current police check for sighting.

- The failure or unsuitability of facilities (including grand-stands and fences) to ensure my safety.

EXCLUSION OF LIABILITY, RELEASE & INDEMNITY

In exchange for being able to attend or participate in the Equestrian Activities, I agree: To release Boneo Park and the Entities to the extent that any or all of them are providing Recreational Services from all liability for:

- My death;
- Any physical or mental injury (including the aggravation, acceleration or recurrence of such an injury);
- The contraction, aggravation or acceleration of a disease;
- The coming into existence, the aggravation, acceleration or recurrence of any other condition, Circumstance, occurrence, activity, form of behavior, course of conduct or state of affairs:
- O that is or may be harmful or disadvantageous to me or the community; or
- O that may result in harm or disadvantage to me or the community, howsoever arising from my Participation in or attendance at the Equestrian Activities;
- O to indemnify and hold harmless and keep indemnified BPE and the Entities to the maximum extent permitted by law in respect of any Claim by any person; and
- O to attend at or participate in the Equestrian Activities at my own risk.

I understand that:

- Nothing in this document excludes, restricts or modifies any rights that I may have as a result of significant personal injury that is caused by the Reckless Conduct of Boneo Park and the Entities as the supplier of the Equestrian Activities / Recreational Services;
- Nothing in this document prevents the Entities from relying on any laws (including statute and Common law) that limit or preclude their liability;
- Nothing in this document excludes any term or guarantee which under statute cannot be excluded; However the liability of the Entities is limited to the minimum liability allowable by law;

WARNING UNDER THE AUSTRALIAN CONSUMER LAW AND FAIR TRADING ACT 2012 Under the Australian Consumer Law (Victoria), several statutory guarantees apply to the supply of goods and services.
